

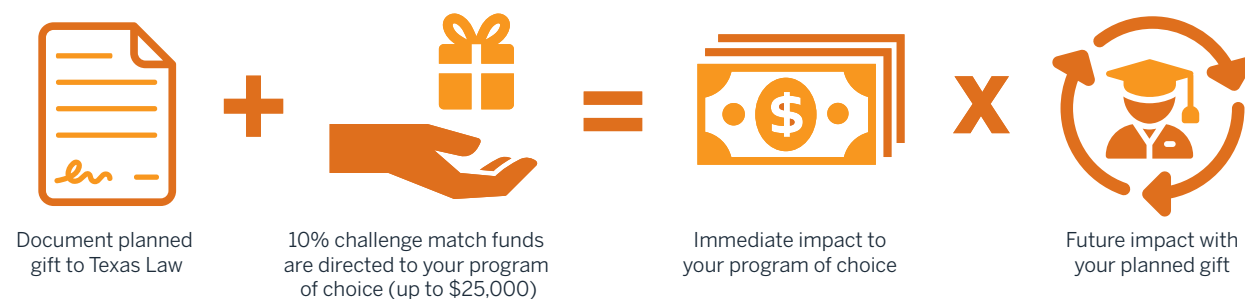
# TEXAS LAW LEGACY CHALLENGE

## Create an Impact Today and Tomorrow

### Texas Law invites you to join the first-of-its-kind Legacy Challenge.

Thanks to a generous grant from the University of Texas Law School Foundation, a matching gift of \$10,000 to \$25,000 will be made in your name when you document a new planned gift of \$100,000 or more to support Texas Law. The matching gift will be made as an immediate donation (while funds last) to support a project or program that you choose within the Law School.

### How does the match work?



### How much of my gift will be matched?

Matches are first-come, first-served while funds last and will equal 10% of your planned gift up to \$25,000. For example:

*Your \$100,000 planned gift will receive will a \$10,000 match donated in your honor and to be used immediately for your preferred program or project at the Law School. Any planned gift over \$250,000 will receive \$25,000 in matching funds. Again, while matching funds are available.*

### Where can I designate my matching funds?

You can designate your matching funds to:

- Current-use Scholarships
- Loan Repayment Assistant Program (LRAP)
- Pipeline Program (a diversity, equity, access, and inclusion project)
- Dean's Fund for current needs at Texas Law
- Your favorite program at the Law School

## What types of planned gifts qualify for the Texas Law Legacy Challenge?

Your planned gift may be made through any method that best serves your goals. Some examples of planned gifts eligible for matching funds include bequests, beneficiary designations on a retirement account, bank account, or life insurance policy given to the Law School, as well as charitable gift annuities, charitable remainder trusts, and charitable lead trusts. We have donor advisors who can walk through these options with you.

## Why is it important to document my planned gift?

Most importantly, we want to understand your wishes. When you intend to make a planned gift, documenting that gift now provides a critical opportunity to explore what is most meaningful for you and consider ways that Law School can plan for the greatest impact of your planned gift. We also would like very much to acknowledge your generosity, say thank you, and welcome you into the Texas Leadership Society (optional), a family of over 2,000 generous Longhorn alumni and friends who receive special recognition and enjoy distinctive experiences as insiders.
